Totah Rabbit Breeders and Rio Grande Valley Rabbit Breeders Association, reserve the right to remove anyone disrupting the show or other exhibitors.

NM State convention banquet will be held at the Panda Garden 1100 West Broadway Bloomfield, NM, after the show. Each person attending will pay for their own meal from the menu.

SHOW RULES

1. **ENTRY FEES:** See entry forms for correct fees for each show. All fees must be paid prior to the beginning of judging. All rabbits entered in fur must also be entered in its own breed class. There will be a \$35.00 service charge added to any check returned not paid by your bank.
2. Entries must be postmarked by required dates on entry forms. Call-ins and e-mails will be accepted by the deadlines set forth on the entry forms. Please be courteous and honor this time frame. Fees for call-ins/e-mails payable before 8:00 am the day of the show or the animal will be scratched. **Acceptance of an e-mail is considered an official entry and the exhibitor is liable for the full amount of the entry.**
3. All animals showing signs of disease shall be removed from the showroom (sec. 31 show sponsor rules of ARBA.)
4. All rabbits entered in the youth show **MUST BE** carried to the table by a youth. Youth exhibitors may enter sanctioned youth shows through the age of 18 yrs. Adults cannot show in Youth classes. Youth may not enter the same rabbit in both open and youth shows at the same show. Youth may enter in both open and youth shows with different animals. Youth members must be 5 years of age or older, if the age of the youth is in question you must be able to provide proof of age for the child.
5. Judging will begin at 8:30 AM-SHARP!!! All rabbits must be checked and entries paid prior to 8:30am.
6. Substitutions will be taken at the time of judging. **SUBSTITUTIONS** will be allowed in the **SAME BREED, CLASS, VARIETY AND SEX.** **NO OUT OF CLASS SUBSTITUTIONS.** (This rule applies to the all breed show, only.)
7. Club reserves the rights to call entrants collect if their entry is incomplete or unclear.
8. Exhibitors will be responsible for getting their rabbits to the judging table as soon as the class is called. Rabbits will be called three (3) times if not on the table after the final call the class will be closed. **NO REJUDGING OF A CLASS.**
9. All entries **MUST** have a **PERMANENT, LEGIBLE EAR MARK** in the **LEFT EAR**, or they will be disqualified.
10. All rights reserved to substitute judges in any event. Superintendent reserves the right to make any changes he/she deems necessary. Judging order will be posted the day of the show. No one is allowed in the judging area except for show officials and assistants.
11. **PLEASE KEEP YOUR AREA CLEAN. NO SMOKING IN THE BUILDING. NO ALCOHOLIC BEVERAGES ALLOWED.** **PLEASE KEEP TRACK OF YOUR CHILDREN.**
12. Rio Grande Valley RBA, Totah RBA, the owner, agent, or management of the show facility, or any other related organization will **NOT BE HELD RESPONSIBLE** for any type of theft, accident, or personal injury to any person or personal property, (whether owned, borrowed, or rented,) due to neglect, or any other cause.
13. **NO DOGS ALLOWED IN THE SHOW ROOM OTHER THAN SERVICE DOGS.** Violators of this rule will be asked to leave the show room and your entry will be forfeited. Dogs may have been allowed in the past but will not be tolerated at this show. **NO EXCEPTIONS.** This is a McGee park requirement and violators will be asked to leave.
14. This is a no comment card show. No awards will be mailed to exhibitor.
